This has reference to your proposal No. VN/affi/12/001, dated 29/10/2012 and subsequent letter dated 7/06/2013, requesting for first time affiliation to start new college of Engineering from the academic year 2013-14 imparting branches of 1) Mechanical Engg. (120), 2) Computer Engg., 3) Electronics & Telecommunication Engg. and 4) Civil Engg. with intake 60 students in each branch on the name of Vishwaniketan's Institute of Management Entrepreneurship and Engineering Technology proposed to be started at Survey No. 52, Kumbhivali, Near Khalapur Toll Naka, Off. Mumbai Pune Exp. Highway. Tal – Khalapur, Dist – Raigad – 410 202.

In this connection, I am directed to inform you that considering the permission granted by the above mentioned authorities to your Sanstha, I am please to inform you that your Sanstha has been granted permission for first time affiliation to start new college of Engineering from the academic year 2013-14 imparting branches of 1) Mechanical Engg. (120), 2) Computer Engg., 3) Electronics & Telecommunication Engg. and 4) Civil Engg. with intake 60 students in each branch on the name of Vishwaniketan's Institute of Management Entrepreneurship and Engineering Technology propose to be started at Survey No. 52, Kumbhivali, Near Khalapur Toll Naka, Off. Mumbai Pune Exp. Highway. Tal – Khalapur, Dist – Raigad – 410 202, on permanently "**No Grant Basis**" to start the first year classes only of the 1) Mechanical Engg. with intake of (120), 2) Computer Engg., 3) Electronics & Telecommunication Engg. and 4) Civil Engg. with intake 60 students in each branch from the academic year 2013-14.

The college has to fulfill the conditions mentioned in the above referred Government Resolutions and also to fulfill the following affiliation conditions –

- 1) that the conditions laid down by the University from time to time.
- 2) that the minimum attendance of all the students must not be less than 75% during the academic year and college will have to complete syllabus of all the subjects during the academic year.
- 3) admissions should not be linked with donations.
- 4) that the college will strictly follow the Ordinance 2802 in respect of preventing the colleges and Management of Colleges from accepting donation or capitation fees for admission of students in the Colleges, quoted in the University Circular No.Aff./Recog./49 of 1987, dated 4th February, 1987 (copy enclosed.)
- 5) that college should follow the norms as prescribed and circulated by the University vide No.CONCOL/75 of 1988, dated 3rd March, 1988 (copy enclosed).
- 6) the college shall not admit the students over and above sanctioned intake.
- 7) the college shall appoint the teaching as well as non-teaching faculty as per the University and U.G.C. norms and also provide infrastructure facilities for the purpose.
